MAKID provides a comprehensive solution for music producers:

- Desktop Application: Syncs with your Ableton Live files, displaying project data including tempo,

last modification date, and associated bounces for in-app playback.

- Mobile Application: Extends the functionality with cloud storage for exported MP3 audio and

immediate playback features. This mobile version is available for both iOS and Android platforms.

- Premium Services: Includes additional features available for a monthly subscription fee.

3. Registration and Account Integrity

You may be required to register and create an account to access certain features of the Service.

You agree to provide accurate and complete information and keep this information up to date. You

are responsible for maintaining the confidentiality of your account credentials and for all activities
